#### Quotations

Quotations are valid for 28 calendar days from the date of issue.

Acceptance of a quotation, in full or part, means you agree to our conditions of sale.

#### **Order confirmation**

To confirm and accept your order a mobilisation payment of 50% is required. Once we have received cleared funds your order will be considered to be confirmed. Your mobilisation payment acts as confirmation of your order. All balances are due prior to fitting, installation, delivery or collection of goods.

Once monies have been received by us there is a 48 hour cooling off period whereby you can cancel your order and obtain a full refund of your deposit. After that time your mobilisation payment is non-refundable and the full amount of the order is payable. We reserve the right to agree to alternative arrangements for order confirmation from those stated in this agreement.

#### **Order Cancellation**

After the 'cooling off' period your order cannot be cancelled.

### **Timescales**

Please note lead times quoted are approximate and subject to change. In light of the pandemic this has affected supply greatly and whilst we try hard to achieve estimated delivery dates sometimes this is out of our control. We accept no liability for consequential loses caused by a delay in your order.

Soft furnishings - are approximate and subject to change if fabric is unavailable or faulty. An approximate lead time for made to measure goods is approximately 6 weeks from order confirmation.

## **Payment**

Bank transfer / BACS payment is our preferred method of payment.

We accept most but not all credit and debit cards. We accept cheque payment.

For credit / debit card payments we will send a link via our main website through Sagepay which is specific for you and is by prior agreement only, card payments by telephone or any other communication method are not accepted.

We take no responsibility for any manufacturing faults with customer supplied fabric. Goods made by 'making up service' are non- refundable.

### **Colours – Shade Variances**

Please note there may be a slight shade variance to the sample shown / supplied. Shade variances exist due to different production batches by the manufacturer. Shade variance is not an acceptable basis for a customer complaint in relation to products and services provided by us. Shade variance will be within accepted UK manufacturing tolerances.

### **Special Orders & Painted Furniture**

Wallpaper & furniture ordered in specifically for you is considered a "special order" and is not returnable. For wallpaper – please check the quantity required as we do not accept returns on any wallpaper orders. Furniture will be painted as per quotation only and this service is considered as a bespoke service.

## Client's goods

Items stored for clients by prior agreement will be held for no longer than 6 months. If after that time the client fails to collect after notification Portobello Interiors reserves the right to dispose of items held.

## Guarantee

Soft furnishings, upholstery, blinds, furniture, poles and tracks supplied by us are guaranteed for one year from date of installation. Shutters are guaranteed for 3 years from date of installation. This guarantee does not include accidental or deliberate damage or damage caused by external factors including but not limited to damage caused by sunlight, moisture and excessive heat. Call out charges may apply if upon inspection by us, damage has been caused factors outside the scope of the guarantee.

Furniture, hinges – runner's handles are covered for one year from date of purchase. General wear and tear is deemed as acceptable along with minor marks from usage.

If furniture is assembled by the client and the furniture suffers damage we accept no responsibility for the damage.
